We strive to offer our attendees a diverse selection of unique artist wares as well as products that are not available elsewhere.

We are offering "booth spaces" (10' X 10') to a limited number of booths are available. Vendors will be admitted based on space availability as well as product distinction.

### **Please note the following important information:**

- Vendors will be required to participate both days of the event
- Booths may not be shared; anyone selling their wares must go through the application process.
- Arts & Crafts Vendors will be provided a 10' X 10' booth.
- The vendor is responsible for paying the cost of the tent as provided by NMJW at our cost.  
***(Note: vendors are not allowed to use their own tents.)***
- Vendors will be responsible for providing all booth furniture and equipment to be used in the booth.

**Fee:** The reservation fee for the two-day event for their 10'x10' exhibit space is \$100.00 plus the booth fee (\$100.00).

### **Payment Schedule:**

Applications are due by September 4, 2018, along with 50% payment (\$50.00) . Final payment and booth fee is due subject to selection on or before September 7<sup>th</sup>, 2018.

To be considered, please print out the application on the following page, fill it out and submit it, along with a 50% deposit (\$50.00). If you do not have a website where your products/artwork may be viewed, you may wish to submit photographs, either via email or snail mail. It's not required, but it would be helpful in making our evaluations and determining vendor placements.
